PARKING LOT REGULATIONS
AND
PENALTIES FOR VIOLATIONS

Parents, you will notice that most of these rules will specify the student because we realize that the parent would be least likely to violate the rules. However, depending on the decision of the board, if a violation occurs involving the parent driver, there may also be penalties incurred.

- ❖ Always use restraint when in the parking lot. **The speed limit is 10mph. until you reach the Nubbins Ridge Road.**
- ❖ Display official permit sticker (no copies) on the rear window of the vehicle.
- ❖ This permit is non-transferable.
- ❖ If any information changes (new stickers, etc.) for the car that the permit is for, changes must be made on the official application.
- ❖ If the student gets a new car that will be driven to TC, a new application must be submitted BEFORE the car will be allowed at TC. Parents, you will also need to let us know if you have a vehicle change and fill out a new application as soon as possible.
- ❖ PARENTS may call for a temporary (1-2 wks) permit number, if needed while main vehicle is being serviced. All descriptive detail information must be given about the car that will be driven before a temporary number will be issued.
 - If the student is found to break any rules, the student will lose the privilege to drive and/or will pay a fine for the offense.
 - If there is an offense and the TC board revokes the permit, the student must resubmit an application to drive to TC in the next semester.
 - The board may choose other methods of correction on a case to case basis.
